## **Aquatic Management Plan** – Steve Hunnicut

The Lake Association will sign a contract allowing the survey and identification of invasive plants. If any invasive plants are found they would set a plan of action. The overall cost would be about \$3500. It is a requirement of the DNR for cost sharing for invasive species infestation. **Step 1**: Every owner gets a survey, please complete and fill out. **Step 2**: June starts the curly leaf pond weed search. July and August completes the plant survey part. **Step 3**: Public meeting to discuss results of survey and decide 4-6 objectives. Need to form a subcommittee, members needed, please sign up. If we would have a serious problem, it would be a 10 year plan and very expensive.

# **Treasurer's report:**

As of May 23, 2015 we have a balance of \$1,828.13.60 in the checking account. There is 4,830.00 in the Special Fund.

**Dave Bjarnaso**n spoke on Loon Symposium in Ashland WI. 7 Loon eggs were laid, no babies due to black flies chasing loons off of nest. Nothing we can do. We tried cedar chips on platforms this year, not helping much. Common causes of loon death: mercury poisoning, lead poisoning and botulism.
