Loons update- Dave Bjarnason

- Ice out May 3, platforms were out that week
- Loons arrived (5/1) before ice was out
- North Nest: north platform moved due to no loon chick production on platform the past 2 years at that site. Pair of loons in the area.
- Middle Nest: pair of loons present, egg laid on platform but black flies drove loons off, egg removed- will see if relay egg
- South Nest: pair of loons, one on nest

4 No Wake Signs Missing last year: suspected they were stolen

Aquatic Invasive Species update: Bob

- Purple loosestrife: high water has helped us, we made it around the whole lake last year
- Chinese Mystery Snails
- Brown Banded Snail

Vote in New Treasurer

Decontamination Station

- Bleach water solution and gallon sprayer to spray boats
- Place station between Long lake and Des Moines Lake, county will pay for the sign, construction materials, and initial equipment and supplies. It was not known who would be responsible for the cost of ongoing equipment and supplies.
- Who will monitor? Who will make sure solution is full?
- Des Moines Lake Association is basically none existent
- Burnett County law has been amended to require that all boats in or out must be decontaminated. A question was raised can lake property owners be given an exemption for single lake usage where boat is being stored for 4 or more months.
- Main Store tests their boat repairs in our lake
- The company who put docks in were seen not cleaning their barge
- Who monitors the boat ramp?
- Operating budget? Lots of questions, not a lot of answers
- Do birds spread invasive species? Mixed answers

Other Business

- Boats out past sunset with no running lights: Must follow state laws
- Boats going too close to docks, 100ft rule for boats, 200ft rule for Jet skis, must follow state laws
- No wake rule 5pm-10am is a Webb Lake Township Ordinance not a Long Lake Association Ordinance
- How should we get more Long Lake property owners to contribute to the lake association? Typically, we average about 50% participation
