Town of Webb Lake Boating Ordinance

We thought this would be a good time to review the Town of Webb Lake boating ordinance. Some boaters are either not aware of the ordinance or don't understand what it requires of them.

The ordinance was approved on June 3, 1996. Below are some highlights of the ordinance:

The provisions of this Ordinance shall apply to the waters of Deer, Big Bear, Little Bear, Webb (Upper & Lower), Des Moines, Long, Lucerne, Lily, Prinel, Nicaboyne and Lost Lakes.

State boating laws as founded in ss. 30.50 to 30.71 are adopted by reference.

No person shall operate a boat in the following area at a speed faster than "Slow – No Wake", as defined in 30.50(12), Wisconsin Statues 1988, as "that speed at which a boat moves as slowly as possible while still maintaining steerage control." Said "No Wake" areas are: All the lakes as listed above between the hours of 5:00 PM to 10:00 AM.

Wisconsin state boating penalties as founded in ss. 30.80 are adopted by reference.

Aquatic Invasive Species Point Intercept Survey

Burnett County Land Services Department performed an aquatic invasive species (AIS) point intercept survey of Long Lake on June 3. The point intercept method was used with the standard Wisconsin Department of Natural Resources (WDNR) aquatic plant sampling protocols. A sampling grid developed by the WDNR was utilized. Sampling grids are designed with each waterbody's unique characteristics in mind—shape, size, and depth are some examples of factors that are used. All sampling points within the littoral zone (area of plant growth) were sampled.

According to Tom Boisvert, Burnett County AIS Coordinator, using the point survey method may be the most effective method possible. It examines the entire littoral zone.

The survey did not reveal any new AIS in Long Lake. They observed Chinese and banded mystery snails as well as purple loosestrife, which were known to be present before the survey. Efforts to control purple loosestrife by supplementing the beetle population are planned for this summer.

Tom also said Long Lake appeared to have a healthy and thriving aquatic community.

The cost of the survey was \$1,306.09.

Clean Boats Clean Waters

This is our second year being a part of the Clean Boats Clean Waters (CBCW) program. The program is a statewide preventative program that is dedicated to keeping invasive species out of the state's lakes.

If you have been to the landing this year will have noticed that the association has installed two cameras for surveillance. In addition, on the weekends there are several people who have volunteered their time to be boat inspectors. The purpose of the inspectors is mostly for education. But they also ask questions concerning the type of use and where the launching watercraft have been. That information gets put into a statewide database.

We have been fortunate to have 12 different people act as inspectors this summer. Mark Michel said he has heard from volunteers that the time spent at the landing can be very enjoyable. They get to meet lake neighbors that they would not necessarily get to know. Volunteers usually sign up for a two-hour block of time. Many choose the same time block each weekend, although not everyone can do every weekend. Oftentimes a couple will choose to be at the landing together.

We always welcome new inspectors. If anyone is interested in joining the group, please ask one of the volunteers or contact Mark Michel at 715-281-8953.

On a side note, as part of the program, the association has a dedicated pontoon trailer for use only on Long Lake. Please keep that in mind as you start to think about pulling your pontoon out. Cost is \$25. Call Mark Michel at 715-281-8953 to arrange a time for use.
