Loon Watch Update

David Bjarnason relinquished his Loon Ranger responsibilities for Long Lake at the 2023 annual member meeting. Please thank Dave for his many dedicated years of monitoring and reporting on the loon population each year.

Candy McMahon, a full-time resident on Long Lake, accepted the role of Loon Ranger for Long Lake last July. She plans to share lots of information about the program and her role as a Loon Ranger on the Long Lake Facebook page, in this newsletter, and at member meetings. Below is her report for 2023:

"I completed all the information I gathered for the Loon Watch Monitoring since I began monitoring in July 2023. I made copies for my records, mailed the packet 10/24/2023 to Erica Lemoine at the Loon Watch office in Ashland, WI.

It was a very interesting loon season for Long Lake. No chicks thrived to young adults; the one chick that hatched in the north section disappeared on day two after hatching. The mate to the north section pair disappeared in August and was never seen again. We searched the shorelines, watched, and looked with binoculars but did not see that mate again.

The middle section pair (no chicks) took off in late August, the north and south section loons (no chicks hatched) took off in late September/very early October. Hoping for a much better season in 2024!"



Clean Boat Clean Waters (CBCW) Program Update for 2023

We had a good turnout in 2023 for both paid and volunteer boat inspectors for monitoring the boat landing. The CBCW program is an important Wisconsin DNR sponsored program to help alleviate the spread of aquatic invasive species in Wisconsin lakes. Boat inspectors help perform boat and trailer checks, hand out informational

Last year, the following association members performed 227 hours of boat inspections: Chris Franken, Beth Ihry, Amy Juers, Jim Koren, Brian and Amy Laven, John McMahon, Mark Michel, Phil and Pam Miller, Bob Peterson, Jim and Jeanine Sundberg.

Please thank them next time you see them for their efforts in helping to keep invasive species out of Long Lake.

The CBCW grant reimbursement request in the amount of \$1,350 for last year was submitted to the Wisconsin DNR in November.

Wake Boat Information

Your association wants to keep members abreast of the latest Wisconsin news regarding wake boats. It is important to remember that the association is not advocating a pro or con position on wake boats.

Wisconsin is advocating for a state law to prohibit wake-enhanced boating on lakes smaller than 1,500 acres and within 700 feet of shore. Such a statute would allow wake boat activity on an estimated 77 lakes in Wisconsin.

Long Lake is 251 acres. It is long and narrow with the widest part about 1,700 feet. The deepest part is about 40 feet deep, with most of the lake less than 20 feet deep.

In addition to state level activity, The Burnett County Lakes and Rivers Association (BCLRA) along with Rooney, Fish, and McKenzie Lake associations is promoting a new ordinance for Scott Township. The ordinance would prohibit wake boats from wakesurfing or using wake enhancements. Wake boats could still be used for other activities like water skiing, tubing, and fishing. The ordinance would not include Long Lake unless it was also approved by Webb Lake Township, because 60% of Long Lake is not in Scott Township.

Don't Be on Thin Ice

Please be alert for possible hazardous conditions like thin ice if you go out on the lake this winter due to the mild winter weather. You can consider making sure someone knows you're out on the lake and where you'll be, stay on marked trails, and you could even consider carrying a personal flotation device.
