**3. Dave Foote:**

**4. Candy McMahon ~ Loon Watch update:**

Currently as of 5/25/24: Black flies were present soon after eggs were laid, flies were gone about 2 weeks after fly hatch. NORTH nest has 1 unattended egg, loons not around nest. MIDDLE nest has 2 eggs with loon on nest. SOUTH nest has 2 eggs with loon on nest.

**5. Safety Poster:**

Posters and DNR handbook handed out to all property owners present and the meeting, Teams will deliver posters and DNR handbook door-to-door to all cabins/homes of property owners not present at the annual meeting.

**6. Mark Michel CBCW:**

Mark gave update on new heated, pressurized power washing system at the boat landing. The newly drilled sand point well is working good, pad under the pump will be added soon. System is co-owned with the Des Moines Lake Association. The LLA portion cost is \$7,500 to be paid from the AIS fund. Annual operating costs to be approximately under \$1K/year to be shared by the LLA and Des Moines Lake Association. Brad Zeller stated there is now a camera near the lake edge, wifi working to monitor boats that may be power loading boat to trailer.

**7. Mark Michel Loosestrife Update:**

Mark is attempting to grow beetles again this summer.

Teams worked in August, 2023 to clip and spray the area to slow the plant growth. Sign up sheet present to help with spraying in August, 2024.

**8. Dave Foote Wake Boat Legislation Update:** There are legislative bills in the works to possibly change wake boat use to restrict wake boats on lakes under 1500 This is an ongoing project.
